<p>PURPOSE/REQUIRED ACTION: The purpose of this agenda item is for Council to hold a second public hearing to receive citizens' comments on the 2009-2010 Mid-Biennial Budget Review and Update. A discussion will follow the public hearing.</p> <p>BACKGROUND (Include prior Council action & discussion): The 2009-2010 Biennial Budget was adopted on November 17, 2008 (Ordinance #500) and was amended on June 15, 2009 in response to the ongoing recession and declining revenues (Ordinance #513). The June amendments included changes to the 2010 revenues and expenditures. This mid-biennium review only addresses items that need budgetary changes for the second of the two years.</p> <p>The first public hearing was conducted on November 9, 2009, during the regular City Council meeting.</p> <p>Adoption of the 2009-2010 Budget Modification and the 2010 Property Tax Levy is scheduled for November 23, 2009, after the second public hearing and Council discussion. This date may be extended (to any date prior to January 1, 2010) if Council decides to continue discussion of the 2009-2010 Mid-Biennial Budget Review and Update.</p> <p>OPTIONS (Including fiscal impacts): N/A</p>
