<p>PURPOSE/REQUIRED ACTION: Community Animal Resources Education Society (C.A.R.E.S.) will update the Council on the services they provide Burien per their contract with the City. This presentation is at the request of the Council.</p> <p>BACKGROUND (Include prior Council action & discussion):</p> <p>On June 15 the non-profit group Community Animal Resource Education Society, or C.A.R.E.S., began providing animal care and control services for Burien. The services they provide include:</p> <ul style="list-style-type: none"> • Enforcement of Burien Municipal Code Title 6 -Animals • Dog Bites/Dangerous Dog Reports • Impoundment of stray dogs • Rescue of sick or injured animals • Educational information about pets and pet ownership • Referral to other animal service agencies <p>CARES is also available twenty-four hours a day, seven days a week, on an emergency response basis. Dispatch centers for both Burien Police and Fire will have an emergency number to call for response to:</p> <ul style="list-style-type: none"> • Vicious animals or animals wild or domestic that may reasonably constitute a hazard to persons or other animals or threaten public safety • Animals with life-threatening injuries • Hardship cases or law enforcement assistance matters <p>The CARES main facility is located at 145 SW 153rd Street in Burien.
